# Principles Behind Blood Spatter Analysis

- **Velocity:** The speed at which blood is projected directly affects the size of the resulting droplets. Higher velocity forces create smaller, more numerous droplets.

indicates a 90-degree impact, while an elongated, elliptical stain indicates a sharper, more acute angle.

- **Directionality:** The pointed end of an elliptical stain points in the direction of travel. This is often indicated by a small, secondary "spine" or "satellite" spatter at the leading edge.

## Spatter Chart: Key Classifications

A standard blood spatter chart classifies patterns into several major categories. Understanding these categories is the first step in pattern interpretation.

## Passive Bloodstains

These stains are created solely by the force of gravity. They are the simplest to

interpret and provide a baseline for understanding the scene. Passive stains typically fall into three sub-categories:

- **Dripped Blood:**

Stains created by blood falling from a bleeding source onto a surface. On a blood spatter chart, these are typically circular and their size depends on the volume of the drop and the height from which it fell.

- **Pooled Blood:** A collection of blood in a depression or on a flat surface, indicating the victim was stationary for a period of time.

clots in a pool or drip trail can help establish a timeline for the injury and the victim's survival time.

## Projected Bloodstains

This category encompasses patterns created when an active force is applied to a blood source. Projected stains are the most informative for reconstructing violent events. The blood spatter chart typically breaks these down by velocity.

**Low Velocity Impact Spatter (LVIS):** This pattern is created by a force traveling at 5 feet per second or slower.

The resulting droplets are relatively large, typically greater than 4 millimeters in diameter. LVIS is often seen in drip patterns or from a bleeding person walking or running.

**Medium Velocity Impact Spatter (MVIS):**

This is the most common pattern associated with blunt force trauma, such as from a hammer, baseball bat, or fist. The force is between 5 and 25 feet per second. A blood spatter chart shows MVIS as a mixture of small and medium-sized droplets, typically 1 to 4 millimeters in diameter. The pattern often features a central void area (where the weapon struck) surrounded by radiating spatter.

**High Velocity Impact Spatter (HVIS):**

This pattern is the hallmark of gunshot wounds. The force exceeds 100 feet per second. HVIS produces an extremely fine mist of blood droplets, many of which are less than 1 millimeter in diameter. A blood spatter chart for HVIS often looks like a fine spray or aerosol, and it can travel significant distances. The pattern can help determine the entry and exit wounds, as well as the position of the shooter.

## Cast-off Patterns

Cast-off patterns are created when a bloodied object swings through the air, flinging blood droplets onto surrounding surfaces. This is a critical pattern for

investigators looking for a weapon. A blood spatter chart for cast-off will show a series of linear or arcing patterns of stains. By analyzing the arc and spacing of these stains, analysts can estimate the number of swings and the type of weapon used. For example, a long, flexible object like a belt will produce a wider, more spread-out arc than a short, rigid object like a hammer.

the heart. This creates a distinctive pattern that rises and falls in a wave-like or spurting fashion. A blood spatter chart identifies arterial patterns by their characteristic "sine wave" appearance on walls or ceilings. The height and duration of the spurts can indicate the specific artery that was severed and provide evidence of a living, beating heart at the time of the injury.

## Arterial Spurt or Gush Patterns

When an artery is severed, blood is forcefully ejected under pressure from

## Transfer and Contact Stains

These patterns are created when a bloodied surface comes into contact

with another surface. A classic example is a bloody handprint or shoeprint. A blood spatter chart classifies these as "wipe" or "smear" patterns. Wipe patterns occur when a non-bloody object moves through an existing bloodstain, altering its appearance. Contact patterns are direct transfers, such as a fingerprint. These patterns are critical for identifying who was at the scene and establishing physical contact between individuals or objects.

## Void Patterns

A void pattern is an area of clean surface within an otherwise continuous blood spatter pattern. The

blood spatter chart teaches analysts to recognize that the absence of blood is just as important as its presence. A void suggests that an object or person was standing between the blood source and the surface at the time of the bloodshed. By analyzing the shape and location of the void, investigators can infer the position of an unseen object or a fleeing person.

While traditional blood spatter charts were hand-drawn and based on physical observation, modern forensic science has integrated powerful technology to enhance accuracy and

multiple impact patterns from different surfaces, software can calculate the "area of convergence" or the point in space where the bloodshed originated. This is crucial for locating where the victim was standing when injured.

- **Create 3D Reconstruction:** A 3D laser scanner creates a digital twin of the crime scene. The blood spatter chart can then be overlaid onto this model, allowing investigators to virtually walk through the scene and test

different hypotheses about weapon type, body positions, and movement.

This technological evolution has elevated the blood spatter chart from a simple set of diagrams to a dynamic, interactive, and highly quantitative analytical framework. However, the foundational knowledge of pattern recognition remains essential. The computer is a tool, but the analyst's trained eye and understanding of the blood spatter chart are what drive accurate interpretation.

### **COMMON MISCONCEPTIONS ABOUT BLOOD SPATTER CHARTS**

Blood spatter evidence is powerful, but it is almost always used as corroborative evidence. It is most effective when combined with DNA

analysis, ballistic evidence, witness testimony, and other forensic disciplines. A blood spatter chart alone cannot convict a suspect, but it can powerfully support the narrative of the crime.
