THE ENDURING APPEAL OF "MARY DID YOU KNOW"

CHORDS FOR INTERMEDIATE AND ADVANCED PLAYERS

In the bridge, the song often modulates or uses a series of secondary dominants to build intensity. The chords for the bridge typically include C, G/B, Am, C7, F, Fm,

and C. The shift from F to Fm (the minor fourth) is one of the most emotionally powerful moments in the song. It colors the lyric "the dead will live again" with a sense of poignant wonder. Mastering these nuanced chord changes will elevate your performance from a simple sing-along to a deeply moving musical experience.
