# Right Major and Courses

These include English, history, political science, philosophy, economics, and any field that requires extensive reading, writing, and analysis. If you choose a STEM or technical major, ensure that you also take humanities and social science courses to demonstrate your communication and critical thinking abilities. can handle the rigorous reading and writing demands of law school, regardless of your discipline.
