# Professional Responsibility

Some versions of the test include basic ethical scenarios, especially for roles that handle confidential client information. Questions may cover conflicts of interest, client confidentiality, billing practices, and communication with opposing counsel. For example:

1. **Scenario:** A paralegal learns that a client has misrepresented facts in a signed affidavit. The paralegal's supervising attorney does

not know. What should the paralegal do?

2. **Options:**

- A. Ignore it since the paralegal is not the attorney.
- B. Report the discrepancy to the supervising attorney immediately.
- C. Confront the client directly.
- D. Withdraw from the case without telling anyone.
