electrolytic cell diagrams are common.

- **Transition Metals and Coordination Chemistry:** Electron configurations of transition metals, coordination numbers, ligands, crystal field theory, and color absorption.

How Topics Connect on the Exam

integrate multiple topics. For instance, a question might combine **equilibrium** with **thermodynamics** by asking you to calculate ΔG° from K_{eq} . TYPES YOU WILL ENCOUNTER
