## KEY COMPONENTS OF A WINNING ONE PAGE BUSINESS PROPOSAL TEMPLATE

### 1. The Header and Title

## HOW TO WRITE A COMPELLING ONE PAGE PROPOSAL USING A TEMPLATE

## Start with Research

Avoid passive voice. Use strong action verbs. Instead of "Work will be performed on a weekly basis," write "We will execute weekly sprints." Your language should convey energy, confidence, and capability.

## Not Features

Every bullet point should answer the question, "So what?" If you list a feature, immediately explain the benefit. For example: "Dedicated project manager (so you have a single point of contact and never wonder who to call)."

## Keep Design Clean and Scannabl

e

Use white space generously. Break up text with short paragraphs, bullet points, and bold headlines. A cluttered page defeats the purpose of a one-page proposal. The design should guide the eye naturally from the top to the bottom.

### **BEST PRACTICES FOR DESIGNING YOUR ONE PAGE BUSINESS PROPOSAL**

### COMMON MISTAKES TO AVOID WITH A ONE PAGE PROPOSAL

## Being Too Vague

While you need to be concise, you cannot be vague. Avoid generic statements. A proposal that says "We will help improve your sales" is weak. A better version is "We will implement a three-step CRM automation workflow

projected to increase close rates by 15%." Specificity builds trust.

## Forgetting the Call to Action

Do not assume the reader knows what to do next. A missing or weak CTA is one of the most common proposal-killers. Make it easy to say yes. Provide a signature block or a direct link to schedule a meeting.

# Without Customiz ation

Templates are guides, not scripts. Failing to customize the content for the specific prospect is a fatal error. Clients can smell a mass-produced proposal from a mile away. Always personalize the problem statement and the solution.
