The use of such tissue has been a political flashpoint in many countries, despite its proven value in developing vaccines (e.g., rubella, polio) and understanding developmental biology. Ethical oversight committees in academic institutions ensure that all research complies with local laws and minimizes any

potential harm or exploitation.
